



- f) To institute awards and scholarships for deserving students and facilitate research programmes
- g) To contribute to 'Institutions' or Trusts or bodies established for any one or more of the objects as mentioned herein above
- h) To do such other acts in addition to and in furtherance of the above objects.

Provided that if at any time hereinafter, it is held that any of the objects of the Trust is not a Charitable object according to Income Tax law, then the other objects of this Trust excluding the objects so held to be not charitable will only be construed to be the objects of the Trust.

Provided that in carrying out any objects of general public utility as mentioned hereinabove, they shall not involve the carrying on of any activity or profit.

The properties shall vest in the Trust.

6. The Founder of the Trust hereby declares that a sum of Rs. 50,000/- (Rupees Fifty Thousand Only) by cash handed over by him to the Trustees has been dedicated for the Charitable purposes and other objects stated above.

The Trustees shall and will stand possessed of the said sum of Rs. 50,000/- (Rupees Fifty Thousand only) upon Trust and also of any other moneys and/or properties which the Trustees may from time to time acquire or receive by way of gifts, donations, or receipts may be accepted for the general purposes of the Trust or for any special or specific purpose connected with the objects of the Trust, indicated by the Donor. All the funds of the Trust and the income arising from the investments of the Trust funds shall be applied for the purpose of the Trust in such manner as the Trustees shall from time to time decide at their meetings in accordance with the objects of the Trust. No part of the Funds or the income shall be utilized for the benefit of any of the Trustees. The Trustees shall meet at least once in three months for the purpose of carrying out the objects of the Trust.

7. Constitution

The number of Trustees shall not be less than TWO and not more than 50 who shall constitute the Board of Trustees.

The following Trustees, who are actively involved in the setting up of the Trust, shall remain as Trustees permanently and shall constitute the "Executive Board of the Trust".

- a) Mr. P.K. AHAMMED
- b) Dr. P.A. IBRAHIM HAJI
- c) Mr. C.P. KUNHU MOHAMMED
- d) Mr. SAMEER KUNHU MOHAMED
- e) Dr. AZAD MOOPEN

The Executive Board shall be responsible for setting the Vision, Mission, Road Map, Governance and Policy matters of the Trust and shall be vested with authority to oversee and direct the affairs of the Trust as well as intervene if there is any deviation.

8. Additional Trustees shall be nominated to the Trust by the Executive Board on the basis of involvement and investment in the Trust from time to time. There shall be 3 nominees from SAFI among the Trustees, to help in integrating the vision and mission of the Trust with that of SAFI and serving as a bridge with the SAFI Trust. Executive Trustees by unanimous decision can add members to the Executive Board with a ceiling of the Executive Board members being kept as 9.

9. The Trustees, while investing funds of the Trust, SHALL NOT violate provisions of the Income Tax Act, 1961 under section 11 and 13 of the said Act as it is framed now, subject to such modifications, amendments or alterations to the Act that may be made in future. Provided further that no clause above said shall be construed as to permit the Trustees to violate the provisions of Section 11 and 13 of the Income Tax Act, 1961.

10. The Board of Trustees shall constitute a **Managing Committee**, approved by the Executive Board, to manage the day to day affairs of the Trust, subject to the Rules and Regulations of the Trust.
11. The constitution, retirements, dissolution and responsibilities of the Managing Committee will be as follows.

- a) The Managing Committee will constitute of 14 members
- b) The following shall be structure of the Managing Committee

CHAIRMAN :

VICE-CHAIRMAN (2) :

TREASURER :

MEMBERS (Maximum 7)

- c) The term of Office of the Managing Committee shall be 3 years. On the expiry of the Term, Board of Trustees shall nominate a new Managing Committee for a similar period, which is to be ratified by the Executive Board.
- d) The Managing Committee will be vested with the general responsibility of running the affairs of the Trust, in pursuit of its declared objectives. It will include hiring or engaging necessary employees, making payments, collecting necessary fund, acquiring assets and disposing them of, operating bank accounts, investing surplus funds, borrowing against security of the assets of the Trust and such other action as are necessary to carry out the objectives of the Trust.

- e) The different functionaries of the Managing Committee will have the duties and responsibilities indicated below. They may also shoulder additional responsibilities as may be assigned by the Board of Trustees from time to time.

CHAIRMAN :

The Chairman will preside over all the meetings of the Executive Committee as well as the Board of Trustees; supervise the functions of the Trust, Executive Committee and other sub-committees and officials.

VICE-CHAIRMAN :

The Vice Chairman will have all the responsibilities of the Chairman, in the absence of the latter. They will also perform such other functions as may be allotted to them by the Board or Chairman.

GENERAL SECRETARY :

The Secretary will convene all the meetings of the Board of Trustees as well as the Executive Committee and execute their decisions and directions. He will maintain all the records and documents including the minutes of the meetings of the Trust and the Executive Committee. He will also supervise the day-to-day administrations of the Trust and its affairs represent the Trust in all courts of law and in all offices of the Central and State Governments and local administration bodies.

JOINT SECRETARY :

The Joint Secretary will have all the powers and responsibilities of the Secretary in the absence of the latter. He will perform such other function as are assigned to him.

TREASURER :

The Treasurer will be the custodian of all the funds of the Trust and will keep proper accounts of all receipts and payments.

12. The quorum for a meeting of Executive Board shall be 3, for the Managing Committee 7 and for the Board of Trustees will be one third of total number ...
13. A member of the Board of Trustees, except the 5 Permanent Trustees, can be removed by a majority decision of 2/3rd of the total members.
14. For all routine matters in the Executive Board, Managing Committee or the Board of Trust, the decision of the majority of the Trustees shall prevail. In case of any deadlock in the Managing Committee. The Executive Board has the right to take appropriate decision for smooth functioning of the Trust including the dissolution of the Managing Committee.
15. The fixed and immovable assets such as land, building etc. for the Trust can be disposed of only by the decision of the Executive Board. The Board may authorize, the Managing Committee to do such act of acquiring and disposing of immovable properties if it finds fit to do so.
16. The Managing Committee shall keep a true and correct account of all the Trust monies and the disbursements thereof and the accounts shall be made up to the end of 31st March every year. The accounts shall be audited by a Chartered Accountant.

17. If for any reason the Trustees feel that they cannot carry on the objects of the Trust themselves, they shall transfer the funds of the Trust then available with its obligations and liabilities to any other Trust or Charitable institutions having similar objects and which enjoys recognition under Section 80 G of the Income Tax Act, 1961 as amended from time to time and the decision of the Trustees in this respect shall be final and no amendment shall be made to the rules and regulations of the Trust which will be repugnant to the provisions of Section 2 (15), 11, 12, 13 and 80 G of the Income Tax Act, 1961 as amended from time to time.
18. This trust is to be governed by the provisions of "The Indian Trust Act".
19. Any clauses in this deed of Trust may be amended or added to only with two third majority of the Board of Trustees ratified by the Executive Board and such amendments will form part and parcel of this Trust Deed. However, such amendment or addition to the Deed shall be made only with the prior approval of the Commissioner of Income Tax.
20. The benefit of the Trust shall be open to all irrespective of caste, creed and religion.
21. The funds and Income of the Trust shall be solely utilized for the achievement of the objectives and no portion of it shall be utilized for payment to the Trustees/members by way of profit/interest, dividend, etc.

IT IS HEREBY EXPRESSLY DECLARED THAT THE TRUST IS ABSOLUTE AND IRREVOCABLE.
